1. Approval of Meeting Minutes – May 18, 2023

The meeting minutes were approved.

2. Matters arising from Meeting Minutes - May 18, 2023

There were no matters arising from the meeting minutes.

3. Standardized form for NI 24-101 Trade Matching Statement

Jamie reported that the OWG concluded that there was utility in the standardized Trade Matching Statement ("TMS") and having such posted on the IIAC website would be useful.

There were some minor updates to the TMS reviewed by the LRWG (a marked and clean version of the TMS was included in the meeting materials). There were no comments on the TMS amendments.

The next step is that the IIAC will review and if it endorses the TMS, the TMS will be posted on the publicly available part of the IIAC website.

4. Other Business

There was a question raised concerning the cut-off time to issue a recall for a securities loan (i.e. would it be 11:59 p.m.).

Keith advised that the Canadian Securities Lending Association ("CASLA") is actively involved in T+1 and the impact on securities lending, including discussions with: third-party vendors to automate, standardize and track recalls (making the process interoperable), the TMX/CDS to explore matching "long" inventory holders with "short" holders, and SIFMA to maintain alignment in the securities lending markets. The initial investigation into the items are expected to conclude in July 2023.

Jamie reported that the master securities lending agreements (e.g. SIFMA's MLSA) were amended to be agnostic as to settlement cycle length and as such, no further amendments are required.
