3. Parties subject to NI 24-101 regarding ITM - Summary of Requirements

Jamie presented a document titled "Parties subject to NI 24-101 regarding ITM - Summary of Requirements". The document outlines key securities law definitions and requirements, and companion policy items concerning institutional trade matching ("ITM"). The document is intended to provide an overview.

In response to a question concerning compliance with the requirements, it was noted that the New SRO oversees dealers while the securities regulatory authorities oversee advisers.

Jamie advised that the document will be presented to the Buy-Side Task Force at its next meeting.

Muneeb Ahsan of New SRO reported that the New SRO published its proposed rule amendments for T+1.¹ The comment period ends June 19, 2023.

Access Standards	FundSERV will be making changes to its Data Standards in regards to T+1. The MFWG has approved the proposed changes (Issue log MFWG-011) and the FundSERV Standards Steering Committee has also approved.
